Financial Institution

All taxes are due and payable January 1, 2020. Property tax must be paid in full by June 30, 2020 or your account will be considered in arrears. Water and sewer taxes are payable monthly and if not paid after three months water services to your property will be disconnected. To enforce payment of any tax imposed, the council may disconnect the service provided by water and sewer systems. Any account not paid in full by the date on the cut off notice is subject to a \$75.00 penalty.
