GUIDELINES TO BECOME A MEMBER OF THE STEPHENVILLE CROSSING VOLUNTEER FIRE DEPARTMENT

To become a member of the Stephenville Crossing Volunteer Fire Department, the applicant must provide both Court Check and a Certificate of Conduct from the RCMP. The Court Check and Certificate of Conduct must be up to date and concurrent with the application. Council will consider the last 5 years from the date of application as the parameters to be met, and the applicant must have a clean record during these 5 years. However, Council will use its discretion (discretion of the offence not the person) in determining if the offence(s) proceeding the 5 year period of clean behavior were severe enough to warrant rejection of the application.

Examples of severe offences (but not limited to these) which would warrant immediate rejection are:

- Offences which were sexual in nature
- Offences related to pornography
- Murder
- Attempted Murder
- Manslaughter
- Assault with a weapon
- Armed Robbery
- Terrorism
- Theft
- Trafficking Drugs
